Regulation falls into two general categories. Economic regulation seeks, either directly or indirectly, to control prices. Traditionally, the government has sought to prevent monopolies such as electric utilities from raising prices beyond the level that would ensure them reasonable profits.

U.S.â€™EU AIR TRANSPORT AGREEMENT TOWARD AN OPEN AVIATION AREA United States be owned and controlled by a citizen of the United States.<sup>7</sup> In 1938, Congress passed the Civil Aeronautics Act that further restricted foreign ownership of U.S. air carriers.<sup>8</sup> Since this time U.S. ownership and control restrictions evolved little and continue to be a source of friction between the United States and EU.
